

DISCLAIMER RELATING TO ACTIVITY PARTICIPATION AT OUT-DOORS AND DIRTY

On arrival and before commencing any activity you are asked to read this document and sign it as confirmation that you have read, understood, agree with and will be bound by the contents and have notified us of anything which might diminish your suitability to participate. If you are unsure about any of the following you should ask for clarification before signing. You should not sign if you have any concerns, but we regret we cannot allow you to participate in those circumstances. A copy of this disclaimer will be forwarded to you on request, provided you have added your address to the bottom of the form at the time of signing.

- Safety equipment will be provided, and you are required to use/wear it. Failure to make use of the equipment provided or to use it improperly will result in your being unable to participate. You are asked to inform a Marshall immediately if you believe any equipment supplied to you is damaged or faulty, so replacement items can be provided.
- It is an express requirement that all persons participating in the activities/pursuits, or persons in the role of parent, guardian or carer of persons intending to participate in any pursuits/activities note below any condition, medication, disability (mental/physical) illness, disease or medical condition of which you have suffered or complained of that could in any manner affect your safety or the safety of others or in any manner, shape or form impair your ability to participate in such activities/pursuits.
Your signature below confirms your declaration of suitability to participate, including with any existing injuries or conditions, for yourself or for a participant under 18 yrs you are signing on behalf of.
- Safety briefings and training will be given prior to the commencement of each activity, in most cases at the location of that activity, so the equipment/course can be seen and explained, and questions fully answered. You are asked to give these your full attention so you understand the risk involved, and to comply with all/any instructions given. If you have any doubts regarding risk, the usage of the equipment or any instructions given it is your responsibility to request further clarification before embarking on any activity. For this reason you forfeit your entitlement to participate in an activity if you arrive after the briefing has completed.
- Since the rough terrain and physical nature of these activities does incur a risk of injury or death you should be aware **that participation in all activities is entirely at your own risk.** We do not accept responsibility or liability for any injury, loss or damage howsoever arising whether caused by your own actions or the actions of others. All participants are recommended to have adequate personal accident insurance in place for all such activities/pursuits. Your signature confirms you accept that risk, and you understand you are responsible for your own actions and/or involvement.
- Protective clothing will be offered to you prior to commencing activities. You are not compelled to wear it, but should you decide not to you must remain fully clothed, ensure no clothing is loose, and is appropriate for the weather conditions and/or terrain on which the activity is sited. Long hair must be tied and jewellery, scarves or similar removed, and footwear should be sturdy, secure and without heels.
- You confirm you are aware that alcohol is not permitted on the premises, and that if you appear to be affected by same you will not be able to participate, nor entitled to any refund if you are refused admission or asked to cease your activity.
- You confirm you understand we accept no responsibility for any theft, loss or damage of vehicles or personal belongings while you are here and that request for storage of keys, wallets etc or parking of vehicles is at your own risk.
- You accept ODD may on occasion without prior notice have to change /amend the activities booked, if weather conditions, equipment failure or other unforeseen difficulties arise, as per terms and conditions accepted on booking, and that terms agreed by the person making a booking is on behalf of all persons in the party.
- You agree to our request for respectful behaviour while at the park, and consideration for our staff and other customers and our property. For your own safety, and in consideration of our neighbours and other participants, you agree to keep within the boundaries of the park, and within activity waiting areas which shall be marked by fencing, tape or similar demarcation until called forward. To keep to paths, and respect any notices regarding access.
